Councillor Lang: Would like to say a special thanks to the Ladies who prepared the meal.

Christopher Yates: Does the Recreation Commission have permission from the City to have the volunteer electrician work on the electricity for the rink? They have a permit. Mayor Smith replied as long as everything is done by code.

Christopher Yates: Is the campground going to be moved? Mayor Smith replied that they are in discussion regarding the campground.
